2	To commend the Metairie Park Country Day Cajuns boys' basketball team upon winning
3	their second consecutive state championship.
4	WHEREAS, it is with great pride that the citizens of Louisiana have learned that the
5	Metairie Park Country Day Cajuns boys' basketball team won the 2014 Class 1A state
6	basketball championship on Saturday, March 15, by defeating Madison Prep Academy 50-47
7	in the finals of the Louisiana High School Athletic Association Top 28 Boys Basketball
8	Tournament held at McNeese State's Burton Coliseum; and
9	WHEREAS, Saturday's victory marks the Cajuns boys' second consecutive state
10	championship and fifth title dating back to 1977; and
11	WHEREAS, the Cajuns closed out the 2013 - 2014 season with a 28-9 record, and
12	the members of the team performed at the highest level of excellence throughout the season
13	and playoffs; and
14	WHEREAS, despite being seeded fourth in the tournament and suffering numerous
15	injuries to several of their starting players, and with the opponent's last-second, potential
16	game-tying three-pointer falling just short, the Cajuns held on to victory; and
17	WHEREAS, Michael Corchiani, who scored a team-leading fourteen points for the
18	Cajuns and had six rebounds, five assists, and two steals, was named the Most Outstanding
19	Player for the second consecutive year; and

1 WHEREAS, the amazing accomplishments of the team could not have been achieved 2 without the guidance and skills of head coach, Mike McGuire, as well as all of the other 3 individuals who contributed to the success of the team, particularly including trainer 4 Katherine Miller, who helped treat the numerous injuries to the players so they could 5 continue competing; and 6 WHEREAS, the members of the Legislature of Louisiana wish to recognize each of 7 the coaches, managers, and the extraordinary young men of the Cajun basketball team on 8 their much deserved second consecutive championship title which was earned through 9 teamwork, determination, and dedication to the sport of basketball.
