<u>Present law</u> provides that the following are responsive verdicts for theft and attempted theft: guilty of theft or attempted theft of property having a value in excess of \$500, property having a value of less than \$500 but not more than \$300, and property having a value of less than \$300.

<u>Proposed law</u> changes <u>present law</u> amounts to be consistent with the crime of theft as follows: guilty of theft or attempted theft of property in excess of \$1,500, property having a value of less than \$1,500 and more than \$500, and property having a value of less than \$500.
