A CONCURRENT RESOLUTION

2	To express condolences upon the death of Albert "Pyook" Berard, husband, father,
3	grandfather, brother, friend, and world-renowned musician.
4	WHEREAS, it is with deep regret and profound sorrow that the members of the
5	Legislature of Louisiana learned of the death of Albert "Pyook" Berard of Cecilia, Louisiana,
6	on Wednesday, February 26, 2014, at the age of fifty-three; and
7	WHEREAS, born June 26, 1960, in the small town of Cecilia, Mr. Berard was born
8	with the gift of music; and
9	WHEREAS, Mr. Berard began playing the guitar as a young boy, and in high school,
10	started a rock band, in which he played lead guitar; and
11	WHEREAS, Mr. Berard was a founding member of the bands "Basin Brothers" and
12	"Al Berard Cajun Combo" and collaborated with many of South Louisiana's greatest
13	musicians during his career; and
14	WHEREAS, he was proud of his South Louisiana roots, and as a singer, songwriter,
15	fiddle player, and guitarist, he shared his gift of music with the world by playing traditional
16	and original Cajun French music; and
17	WHEREAS, his musical achievements include a grammy nomination in 1991 and
18	numerous awards from the Cajun French Music Association, including Fiddler of the Year
19	in 2007, Song of the Year in 2006, and Recording of the Year in 2002; and

1	WHEREAS, Mr. Berard was a faithful and dedicated parishioner of St. Joseph
2	Catholic Church in Cecilia, a member of the church choir for over forty years, and a member
3	of the Knights of Columbus; and
4	WHEREAS, Mr. Berard is survived by his loving wife of over thirty-two years,
5	Karleen G. Berard; three daughters, Dr. Opal LeBlanc Reon, and husband, Cody, Laura
6	Huval, and husband Adrian, and Maegan Berard; two brothers, Jim Berard and wife, Jackie,
7	and Rex Berard and wife, Belinda; four sisters, Ella Goulas and husband, Ronald, Penny
8	Guidry, Genie Patin and husband, Norton, and Sylvia Charpentier; and three grandchildren
9	Nate, Tex, and Claudia; and
10	WHEREAS, with the death of Mr. Berard, Louisiana has lost one of its finest
11	citizens; and
12	WHEREAS, Mr. Berard, who was admired by all whose lives he touched, leaves
13	behind a rich and unique legacy and is greatly missed; and
14	WHEREAS, the soul of a people is maintained and cultivated by its artists, and
15	through his music, Mr. Berard ensured that Cajun heritage would remain vibrant and sustain
16	kinship among the people of South Louisiana for generations; and
17	WHEREAS, although the death of Mr. Berard has left a tremendous void in his
18	community, his memory shall live forever in the minds and hearts of all who knew and loved
19	him and in the music that he loved dearly.
20	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
21	express sincere and heartfelt condolences upon the death of Albert "Pyook" Berard of
22	Cecilia, does hereby recognize and record for posterity his outstanding accomplishments and
23	contributions as a musician and citizen, and does hereby extend enduring appreciation for
24	the pride and honor that this wonderful man will forever bring to his family, friends,
25	community, state, and nation.
26	BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted
27	to the family of Albert "Pyook" Berard.
