1	AN ACT
2	To enact Subpart C-1 of Part II of Chapter 6 of Title 22 of the Louisiana Revised Statutes
3	of 1950, to be comprised of R.S. 22:1863 through 1865, relative to Maximum
4	Allowable Cost Lists for prescription drugs; to provide with respect to definitions;
5	to provide for the regulation of pharmacy benefit manager's maintenance and use of
6	Maximum Allowable Cost Lists for prescription drugs; to provide with respect to an
7	appeals process; and to provide for related matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. Subpart C-1 of Part II of Chapter 6 of Title 22 of the Louisiana Revised
10	Statutes of 1950, comprised of R.S. 22:1863 through 1865, is hereby enacted to read as
11	follows:
12	Subpart C-1. PHARMACY BENEFIT MANAGER'S MAINTENANCE AND USE
13	OF "MAXIMUM ALLOWABLE COST LISTS" FOR PRESCRIPTION DRUGS
14	<u>§1863. Definitions</u>
15	As used in this Subpart, the following definitions shall apply:
16	(1) "Maximum Allowable Cost List" means a listing of the National Drug
17	Code used by a pharmacy benefits manager setting the maximum allowable cost
18	on which reimbursement to a pharmacy or pharmacist may be based.
19	(2) "NDC" means the National Drug Code, a numerical identifier
20	assigned to all prescription drugs.
21	(3) "Pharmacist" means a licensed pharmacist as defined in R.S.
22	<u>22:1852(8).</u>
23	(4) "Pharmacist services" means products, goods, or services provided
24	as a part of the practice of pharmacy as defined in R.S. 22:1852(9).
25	(5) "Pharmacy" means any appropriately licensed place where
26	prescription drugs are dispensed as defined in R.S. 22:1852(10).

1	(6) "Pharmacy benefits manager" means an entity that administers or
2	manages a pharmacy benefits plan or program.
3	(7) "Pharmacy benefits plan" or "pharmacy benefits program" means
4	a plan or program that pays for, reimburses, covers the cost of, or otherwise
5	provides for pharmacist services to individuals who reside in or are employed
6	in Louisiana.
7	§1864. Requirements for use of the NDC by a pharmacy benefits manager
8	A. Before a pharmacy benefits manager places or continues a particular
9	NDC or Maximum Allowable Cost List, the following requirements shall be
10	<u>met:</u>
11	(1) The prescription drug to which the NDC is assigned shall be listed as
12	"A" or "B" rated in the most recent version of the FDA's Approved Drug
13	Products with Therapeutic Equivalence Evaluations, also known as the Orange
14	Book, or have an "NR" or "NA" rating or a similar rating by a nationally
15	recognized reference.
16	(2) The prescription drug to which the NDC is assigned shall be available
17	for purchase by pharmacies in the state from national or regional wholesalers.
18	(3) The prescription drug to which the NDC is assigned shall not be
19	considered obsolete.
20	<b>B. A pharmacy benefits manager shall be required to:</b>
21	(1) Provide access to its Maximum Allowable Cost List to each pharmacy
22	subject to the list.
23	(2) Update its Maximum Allowable Cost List on a timely basis, but in no
24	event longer than seven calendar days from a change in the methodology on
25	which the Maximum Allowable Cost List is based or in the value of a variable
26	involved in the methodology.
27	(3) Provide a process for each pharmacy subject to the list to review an
28	update to the Maximum Allowable Cost List.
29	<u>§1865. Appeals</u>
30	A. The pharmacy benefits manager shall provide a reasonable

1	administrative appeal procedure to allow pharmacies to challenge maximum
2	allowable costs for a specific NDC or NDCs as not meeting the requirements of
3	this Subpart or being below the cost at which the pharmacy may obtain the
4	NDC. Within seven business days after the applicable fill date, a pharmacy may
5	file an appeal by following the appeal process as provided for in this Subpart.
6	The pharmacy benefits manager shall respond to a challenge within seven
7	business days after receipt of the challenge.
8	<b>B. If an appeal made pursuant to this Section is upheld, the pharmacy</b>
9	benefits manager shall take the following actions:
10	(1) Make the change in the Maximum Allowable Cost List.
11	(2) Permit the challenging pharmacy or pharmacist to reverse and rebill
12	the claim in question.
13	(3) Make the change effective for each similarly situated pharmacy as
14	defined by the payor subject to the Maximum Allowable Cost List.
15	C. If an appeal made pursuant to this Section is denied, the pharmacy
16	benefits manager shall provide the challenging pharmacy or pharmacist the
17	NDC number from national or regional wholesalers operating in Louisiana.
18	<b>D.</b> A violation of this Subpart shall be deemed an unfair or deceptive act
19	and practice pursuant to R.S. 22:1961 et seq.
