12	Tulane University and has been actively engaged in the practice of law since finishing his
13	studies at the University of Paris on a Fulbright Scholarship in 1960; and
14	WHEREAS, James J. Cox has served as the president of both the Southwest
15	Louisiana Trial Lawyers Association and the Southwest Louisiana Bar Association; and
16	WHEREAS, he was a strong supporter of the civil rights movement and has been
17	actively involved in every presidential race since 1960, backing Democrats at every level;

1	WHEREAS, in his three terms in the Louisiana Senate, James J. Cox was a master
2	of consensus building, forging alliances, and ultimately joining with a former adversary to
3	secure millions of additional dollars for funding the education of southwest Louisianians;

6	example to others, he bowed out of legislative service after three terms in the Louisiana
