1	A CONCURRENT RESOLUTION
2	To commend Tynes Hildebrand on receiving the 2014 Dave Dixon Louisiana Sports
3	Leadership Award and for being named to the 2014 Louisiana Sports Hall of Fame
4	Induction Class.
5	WHEREAS, the Dave Dixon Award is presented annually by the Louisiana Sports
6	Writers Association's thirty-member Hall of Fame selection committee to an individual who
7	has played a decisive role as a sports leader or administrator benefitting Louisiana or
8	bringing credit to Louisiana on the national or international level; and
9	WHEREAS, Tynes Hildebrand, a native of Florien in Sabine Parish, won one
10	hundred ninety-one games as head coach at Northwestern State University from 1965 to
11	1980 and served as athletics director from 1983 to 1996; and
12	WHEREAS, as a coach, Mr. Hildebrand ranks third in career wins at Northwestern
13	State University (NSU), led the Demons into NCAA Division I and national tournament
14	appearances at the NAIA level and assisted with the training camp of the 1972 United States
15	Olympic Team at the invitation of legendary coach Henry Iba; and
16	WHEREAS, as an athletic director, Mr. Hildebrand is remembered for steering NSU
17	into the Southland Conference in 1987, and amidst challenging budget situations, for
18	unprecedented competitive and fundraising success, and finally, for mentoring and grooming

1	a steady stream of young athletics administrators who continue to impact today's
2	intercollegiate and professional sports scene; and
3	WHEREAS, Mr. Hildebrand also became a traveling evaluator for the initial round
4	of the NCAA's Division I certification process that every Division I institution must undergo
5	each decade and has served on numerous NCAA committees, including the Division I-AA
6	selection panel, until his retirement in 1996; and
7	WHEREAS, in 1997, he began his current role as an NCAA officials observer in the
8	Southeastern, Big XII, Conference USA, Western Athletic, Southwestern Athletic,
9	Southland and Sun Belt conferences; and
10	WHEREAS, when the NCAA reorganized its basketball officiating administrative
11	structure in 2006, Mr. Hildebrand was chosen to represent the south as one of only four
12	regional representatives who work to evaluate and select officials to work each round of the
13	NCAA Tournament; and
14	WHEREAS, Mr. Hildebrand also works as a presenter, evaluator and instructor
15	during the offseason at numerous officiating clinics; and
16	WHEREAS, throughout his nearly fifty year career, Louisiana's native son Mr.
17	Hildebrand has used his leadership skills and talents to impact college basketball in a
18	positive way and has been an inspiration and role model to his players and assistant coaches
19	as well as other coaches, administrators, officials and colleagues.
20	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
21	commend Tynes Hildebrand on receiving the 2014 Dave Dixon Louisiana Sports Leadership
22	Award and for being named to the 2014 Louisiana Sports Hall of Fame Induction Class.
