11	of 23.37 seconds; and

19	first in the 4x100 meter relay with a time of 45.70 seconds; and

21	placed first in the 4x200 meter relay with a time of 1 minute and 34.43 seconds; and

1	WHEREAS, Rontravion Bryant, Lee Mason, Jeremy Patton, and Rashaan Proctor
2	placed first in the 4x400 meter relay with a time of 3 minutes and 40.27 seconds; and
3	WHEREAS, all members of the New Living Word School track and field team
4	performed at the highest level of excellence throughout the 2014 season, and each of these
5	great Lions deserves recognition for his vital contribution to the winning effort; and
6	WHEREAS, the amazing accomplishments of this team could not have been
