SEX OFFENSE/REGISTRY EN INCREASE GF EX See Note Page 1 of 1  
Provides relative to the in-person periodic renewals of persons who are required to register but do not have a fixed residence address

Present law provides that any person who is required to register as a sex offender or child predator shall periodically renew their registration. Proposed law retains present law and provides that if the person is homeless, or is without a fixed residence, he shall appear in person to renew and update his registration with the sheriff of the parish in which he is homeless, or is living without a fixed residence, every fourteen days from the date on which he initially appeared to register with the sheriff of that parish. Before an offender plans to no longer reside without a fixed residence in a particular parish, proposed law requires him to give notice, in person, to the sheriff of the parish in which he intends to no longer reside. Provides that the failure to comply with proposed law shall be a violation of, and shall be subject to the penalties provided in, the present law provision regarding the failure to register and notify a sex offender or child predator.

**EXPENDITURE EXPLANATION**

The proposed legislation may result in an indeterminable increase in state general fund expenditures if an offender fails to register as stated in proposed law, he can be charged with failure to register. If convicted, he can be subject to the same penalty as provided in present law for failure to register and notify as a sex offender or child predator. The exact fiscal impact of the passage of this legislation is indeterminable, since it is not known how many individuals will be convicted of this crime. However, any offender sentenced to the custody of the Department of Public Safety and Corrections increases expenditures by \$24.39 per day per offender in local facilities.

To the extent that offenders are sentenced and housed in state facilities, the cost per day per offender is \$52.51.

**REVENUE EXPLANATION**

There is no anticipated direct material effect on state revenues as a result of this measure. However, any revenue generated through the imposition of fines as a result of conviction would accrue to local government entities.
