1	A CONCURRENT RESOLUTION
2	To commend Oliver G. "Rick" Richard III upon receiving the honor and rank of
3	Distinguished Eagle Scout, on nomination by the Calcasieu Area Council and having
4	been conferred by the National Executive Board of the Boy Scouts of America.
5	WHEREAS, Rick Richard graduated from Louisiana State University, receiving a
6	Bachelor of Arts degree in 1974 and a Juris Doctor degree in 1977 and Richard went on to
7	earn a Masters of Law degree in Taxation from Georgetown University in 1981; and
8	WHEREAS, while in Washington, D.C., Richard worked for Senator John Breaux
9	as legislative assistant for energy issues from 1978-1981; and
10	WHEREAS, Richard was appointed by President Ronald Reagan to serve on the
11	Federal Energy Regulatory Commission (FERC) as a Commissioner from 1982-1985, where
12	he received the FERC Chairman's Medal and the Distinguished Service Medal from the
13	United States Secretary of Energy for his role in unbundling interstate pipeline markets to
14	create economic opportunities in natural gas markets; and
15	WHEREAS, after time in Washington, D.C., Richard returned to private life and
16	became vice president and general counsel for Tenngasco, a company with oil wells in
17	Tennessee, Kansas, and in the Gulf of Mexico on the Louisiana-Texas border; and
18	WHEREAS, Richard's career led him on to serve as chief executive officer (CEO)

1	and president of Northern Natural Gas Pipeline and, later as chairman, CEO, and president
2	of New Jersey Resources before becoming chairman, CEO, and president of Columbia
3	Energy Group, a seven billion dollar company and a "Fortune 300 Company" as named by
4	Fortune Magazine; and
5	WHEREAS, currently Richard is chairman of CleanFuel USA, and alternative motor
6	fuel company which is the first company in the United States to develop a liquid propane
7	fuel injection engine system; and
8	WHEREAS, using his expertise in the field of petroleum-based energy sources,
9	Richard has served three terms on the National Petroleum Council which is an advisory
10	group to assist the United States Secretary of Energy; and
11	WHEREAS, in conjunction with a very busy professional life, Richard has been
12	active in community and volunteer work such as: work with the United States Chamber of
13	Commerce, a board member of the Paul M. Hebert Law School at LSU, the Nature
14	Conservancy of Louisiana, Coastal Plains Conservatory, and the Calcasieu Area Council of
15	the Boy Scouts of America, among many others; and
16	WHEREAS, currently, Richard is involved in the 2014-2015 McNeese State
17	University Capital Campaign as chairman, making him responsible for raising fifteen million
18	dollars for new schools and new buildings at the University and he is advancement chairman
19	and a member of the executive committee for Calcasieu Area Council of the Boy Scouts of
20	America, which oversees all Eagle Scout Projects and appeals; and
21	WHEREAS, in 2008 Richard helped to oversee the completion of the Camp
22	Edgewood dining hall and contributed one hundred thousand dollars to that worthy
23	Calcasieu area Boy Scout endeavor; and
24	WHEREAS, in recognition of these and other achievements which have sought to
25	enrich the lives of others, to help the United States achieve energy independence, to develop
26	alternative fuels, and to be cognizant of environmental issues, Rick Richard was awarded
27	the honor and rank of Distinguished Eagle Scout.
28	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
29	commend Oliver G. "Rick" Richard III, upon receiving the honor and rank of Distinguished
30	Eagle Scout, on nomination by the Calcasieu Area Council and by action of the National
