SCHOOLS RE1 NO IMPACT See Note

Requires the Department of Education to develop and implement a statewide educational technology plan for public elementary and secondary schools. (8/1/14)

The proposed legislation requires the Department of Education to develop and implement a statewide educational technology plan and specifies what shall be contained in the plan. Further requires the the DOE to conduct a technology assessment, evaluate the current technology readiness of schools, identify the costs for upgrading existing software and equipment, develop a funding strategy and identify and develop funding mechanisms to support implementation of the plan. The bill requires the DOE to conduct and publish a technology readiness assessment, provide ongoing guidance and technical assistance to schools and school systems and report to the legislature by January 15 of each year regarding implementation of the plan and status of the technology readiness of each public school and school system.
