1	A CONCURRENT RESOLUTION
2	To commend Sergeant Chad Stafford of the Ascension Parish Sheriff's Office for his heroic
3	rescue of a two-year-old boy from drowning.
4	WHEREAS, Sergeant Chad Stafford is a veteran of more than fifteen years of the
5	Ascension Parish Sheriff's Office, as well as a native and resident of Gonzales; and
6	WHEREAS, one of the missions of the Ascension Parish Sheriff's Office is to protect
7	life; and
8	WHEREAS, on May 13, 2014, Sergeant Stafford was in the performance of his
9	duties as a civil process server with the Ascension Parish Sheriff's Office when he heard a
10	child screaming at a pond on the grounds of the Mansions of Ivy Lakes apartment complex
11	in Gonzales; and
12	WHEREAS, Sergeant Stafford immediately ran to the bank of the pond and saw a
13	two-year-old boy going under the water at the other end of the pond; and
14	WHEREAS, Sergeant Stafford ran along the bank of the pond and then jumped into
15	the water and swam to the child; and
16	WHEREAS, when Sergeant Stafford arrived at the child only the child's feet were
17	above water; and
18	WHEREAS, the water at that location was over Sergeant Stafford's head; and
19	WHEREAS, Sergeant Stafford pulled the child's head out of the water and swam to
20	the bank of the pond with the child; and

- 1 WHEREAS, due to the prompt action of Sergeant Stafford, the child sustained no
- 2 injuries from the near drowning; and
- 3 WHEREAS, Sergeant Stafford should be commended for his selfless actions in

4 saving the life of a child.

- 5 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
- 6 commend the actions of Sergeant Chad Stafford in performing his duties as an Ascension
- 7 Parish Sheriff's deputy to the highest standards and does hereby record for posterity his
- 8 exemplary response to an emergency which resulted in a life-saving rescue.
- 9 BE IT FURTHER RESOLVED that suitable copies of this Resolution be transmitted

10 to Sergeant Chad Stafford and Ascension Parish Sheriff Jeff Wiley.
