**to operate a track to conduct horse racing within the State of Louisiana. The**  
**commission may grant such a license for a period up to and including ten years.**  
**Nothing in this Subsection shall limit the authority of the commission granted**  
**by state law to fine or suspend an association or terminate racing privileges**  
**granted to an association.**"
