Provides relative to membership of Workers' Compensation Advisory Council

In present law, the Workers' Compensation Advisory Council has 17 members appointed by the governor and confirmed by the Senate. Proposed law provides that to the extent practicable, the nominating organization or entity shall strive for diversity in its appointments to the council, taking into consideration sex, race, ethnicity, and geography. Proposed law requires that the members of the council be domiciled in LA. Proposed law requires that each of the five members of the general public be from a different Public Service Commission district. Proposed law provides the governor shall appoint new members as required in proposed law only through attrition.
