SANITARY CODE: Requests the Department of Health and Hospitals to study and make changes to Sanitary Code regulations providing minimum lot size restrictions to address the negative impact of those provisions on economic development

1	A CONCURRENT RESOLUTION
2	To urge and request the Department of Health and Hospitals to study and make changes to
3	the provisions of the state Sanitary Code which provide for minimum lot size
4	restrictions, including but not limited to those provisions relative to sewerage
5	systems, to address the negative impact of those provisions on economic
6	development within the state of Louisiana, with a specific focus on the prohibitive
7	effect of the provisions on the development of land surrounding False River in Pointe
8	Coupee Parish.
9	WHEREAS, R.S. 40:4 requires the state health officer, acting through the office of
10	public health of the Department of Health and Hospitals, to prepare, promulgate, and enforce
11	rules and regulations embodied within the state Sanitary Code in conformity with a set of
12	guidelines and directives set forth in the statute; and
13	WHEREAS, the public policy of Louisiana is to maintain reasonable standards of
14	construction in the state in order to protect the public health, safety, and welfare of its
15	citizens; and
16	WHEREAS, numerous public and private interests are affected by the promulgation
17	of construction standards, including minimum lot size restrictions relative to sewerage
18	systems; and

1 WHEREAS, the legislature recognizes that construction standards and restrictions 2 must balance the needs of affordability of construction and the protection of the public health 3 and welfare; and 4 WHEREAS, there are provisions within the state Sanitary Code which provide for 5 minimum lot sizes when land is subdivided; and 6 WHEREAS, provisions for minimum lot sizes can have a significant impact on the 7 feasibility and desirability of the purchasing or subdividing of a parcel of land with the intent 8 to construct a residential dwelling or commercial building; and 9 WHEREAS, ease of construction plays a pivotal role in the economic growth and 10 development of this state; and 11 WHEREAS, especially during an economic downturn, it is incumbent upon the 12 leadership of this state to assist its citizens by ensuring that the laws, rules, and regulations 13 of this state meet the goal of providing a reasonable degree of public health, safety, 14 affordability, and welfare. 15 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby 16 urge and request the Department of Health and Hospitals to study and make changes to the 17 provisions of the state Sanitary Code which provide for minimum lot size restrictions, 18 including but not limited to those provisions relative to sewerage systems, to address the 19 negative impact of those provisions on economic development within the state of Louisiana. 20 BE IT FURTHER RESOLVED that the department shall include in its study a 21 specific and focused review of the prohibitive effect of the minimum lot size provisions on 22 the development of land surrounding False River in Pointe Coupee Parish. 23 BE IT FURTHER RESOLVED that the department shall submit a written report of 24 its findings and conclusions, including any recommendations for legislation relative to the 25 issue, and any Sanitary Code changes proposed by the department to the House Committee 26 on Health and Welfare and the Senate Committee on Health and Welfare not later than sixty 27 days prior to the beginning of the 2015 Regular Session of the Legislature of Louisiana. 28 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the 29 secretary of the Department of Health and Hospitals.
