FINANCIAL INSTITUTIONS: Requests the House Committee on Commerce to study the feasibility of state taxes on fees collected by money transmitters and the expected realization of state revenue relative to such taxes

A STUDY REQUEST

2	To the House Committee on Commerce to study the feasibility of levying a state tax on fees
3	collected by money transmitters in the state of Louisiana and the expectation of
4	revenue to be realized from levying such a tax, and whether any other states levy a
5	tax on fees collected by money transmitters and realize resulting revenue, and to
6	report the findings of the committee to the legislature not later than forty-five days
7	prior to the convening of the 2015 Regular Session of the Legislature of Louisiana.
8	WHEREAS, R.S. 6:1032(13) provides that "money transmission" means to engage
9	in the business of the sale or issuance of payment instruments or of receiving money or
10	monetary value for transmission to a location within or outside the United States by any and
11	all means, including but not limited to wire, facsimile, or electronic transfer; and
12	WHEREAS, the term "money transmission" includes the following:
13	(1) Selling or issuing stored value or payment in instruments including checks,
14	money orders, and traveler's checks.
15	(2) Receiving money or monetary value for transmission including by payment
16	instrument, wire, facsimile, electronic transfer, or Automated Clearing House (ACH) debit.
17	(3) Providing third-party bill paying services; and
18	WHEREAS, except for persons exempted from licensing requirements in R.S.
19	6:1034, any person engaged in the business of money transmission or selling checks as a

1	service of for a fee in the state of Louisiana is required to be licensed by the Office of
2	Financial Institutions as required in R.S. 6:1033; and
3	WHEREAS, there are approximately sixty-nine licensed money transmitters,
4	including online companies, with approximately twelve thousand seven hundred and fifty-
5	one physical agent locations in the state of Louisiana; and
6	WHEREAS, the customer of a money transmitter pays a fee to the money transmitter
7	to accept the customer's money and transport the money to the customer's desired location
8	or recipients; and
9	WHEREAS, the state has an interest in protecting customers from the risk that
0	money transmitters will fail to deliver the funds as agreed and cause their customers to lose
11	their money; and
12	WHEREAS, in providing regulation of the industry, the Office of Financial
13	Institutions collects various application, licensing, and examination fees from licensed
14	money transmitters; and
15	WHEREAS, while there may be various taxes imposed related to the online transfer
16	of money, such as E-commerce taxes or foreign recipient taxes, there are no Louisiana taxes
17	imposed for the transmission of money through money transmitters licensed pursuant to R.S.
18	6:1033.
19	THEREFORE, BE IT RESOLVED that the House of Representatives of the
20	Legislature of Louisiana requests the House Committee on Commerce to study the feasibility
21	of levying a state tax on fees collected by money transmitters in the state of Louisiana and
22	the expectation of revenue to be realized from levying such a tax, and whether any other
23	states levy a tax on fees collected by money transmitters and realize resulting revenue, and
24	to report the findings of the committee to the legislature not later than forty-five days prior
25	to the convening of the 2015 Regular Session of the Legislature of Louisiana.
26	BE IT FURTHER RESOLVED that the House Committee on Commerce shall
27	specifically solicit input, recommendations, and advice from the Office of Financial
28	Institutions.
29	BE IT FURTHER RESOLVED that in undertaking the study and issuing

recommendations, the House Committee on Commerce may request documents or data,

- 1 conduct public hearings, hear the testimony of witnesses, and take any other actions that it
- 2 deems necessary to carry out its functions.
