Proposed law provides that "apprentice" shall mean a worker older than 16 years of age where a higher minimum age standard is otherwise fixed by law or rules and regulations. Proposed law provides that the director of apprenticeship may not investigate or conduct hearings regarding prohibited discrimination (e.g. age, disability, veteran status, race, color, religion, sex, national origin, pregnancy, childbirth, sickle cell traits, protected genetic information). Proposed law provides that an apprentice, or the apprentice's authorized representative, may submit any disagreements arising under an apprenticeship agreement (except prohibited discrimination) within 60 days of the final local decision to the Director of Apprenticeship, Louisiana Workforce Commission (LWC). Proposed law shall not be construed to preclude an apprentice from pursuing any remedy to address prohibited discrimination in employment. Proposed law shall not invalidate any of the following: (1) Any collective bargaining agreement between employers and employees establishing higher apprenticeship standards; and (2) Any prohibited discrimination in employment.
