| 11 | 30, 2014, and all statutory authority therefor is continued in accordance with the provisions |
| 12 | of Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950. |
| 13 | Section 2. All statutory authority for the existence of the Department of Economic |
| 14 | Development and the statutory entities made a part of the department as re-created by |
| 15 | Section 1 of this Act shall cease as of July 1, 2019, pursuant to R.S. 49:191. However, the |
| 16 | Department of Economic Development may be re-created prior to such date in accordance |
| 17 | with the provisions of Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of |
| 18 | 1950. |
| 19 | Section 3. The provisions of R.S. 49:193 are hereby superseded to the extent that |
| 20 | those provisions are in conflict with the provisions of this Act. |

This Act shall become effective on June 30, 2014; if vetoed by the 9 governor and subsequently approved by the legislature, this Act shall become effective on 10 June 30, 2014, or on the day following such approval by the legislature, whichever is later.
