2	To enact R.S. 56:317, relative to fishing; to establish the Louisiana Catch and Cook Program
3	within the Department of Wildlife and Fisheries; to allow retail food establishments
4	to prepare certain recreational fish; to provide for the promulgation of rules; to
5	provide penalties, terms, conditions, and requirements; and to provide for related
6	matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 56:317 is hereby enacted to read as follows:
9	§317. Louisiana Catch and Cook Program; preparation of recreational fish in
10	retail food establishments
11	A. Notwithstanding any provision of the state Sanitary Code or any other
12	law or regulation to the contrary, it shall be lawful for retail food establishments
13	to receive and prepare any freshwater or saltwater recreational fish as defined
14	<u>in R.S. 56:8.</u>
15	B.(1) The secretary of the Department of Wildlife and Fisheries is hereby
16	authorized to establish the Louisiana Catch and Cook Program, whereby a
17	retail food establishment is authorized to prepare any fish legally taken by a
18	licensed recreational fisherman for consumption by that recreational fisherman
19	or any person in his party.
20	(2) The program shall be established through the promulgation and
21	adoption of rules and regulations in conjunction with the Department of Health
22	and Hospitals and in accordance with the Administrative Procedure Act. Such
23	rules and regulations shall include but are not limited to the following which

1	shall be enforced by Department of Health and Hospitals, office of public
2	health:
3	(a) The retail food establishment shall complete, date, and have the
4	recreational fisherman who brings the fish in for preparation sign an
5	assumption of risk form. The completed, dated, and signed form shall be
6	maintained at the establishment for a period of no less than ninety days. The
7	establishment shall provide the completed forms to the state health officer upon
8	request.
9	(b) The retail food establishment shall receive only fish that have been
10	cleaned, filleted, placed in clean, food-grade, single-service packaging, and
11	properly refrigerated.
12	(c) The retail food establishment shall inspect the fish for freshness and
13	proper receiving temperature.
14	(d) The fish shall be properly labeled with the date, time, and name of
15	the recreational fisherman.
16	(e) The retail food establishment shall store, prepare, and otherwise
17	handle the fish separately from products being prepared for and served to the
18	general public.
19	(f) The retail food establishment shall store, prepare, and otherwise
20	handle the fish in compliance with provisions of the state Sanitary Code.
21	(g) The retail food establishment shall prepare and serve the fish to the
22	recreational fisherman or any person in his party within four hours of receipt
23	of the fish.
24	(h) Containers, preparation tables, cutting boards, utensils, and other
25	food preparation equipment used to prepare and serve the fish shall be properly
26	cleaned and sanitized in accordance with provisions of the state Sanitary Code
27	prior to use preparing foods to serve to the general public.
28	(i) The fish shall be served directly to the recreational fisherman or any
29	person in his party immediately upon the completion of cooking and shall not
30	be served to the general public.

C. Any retail food establishment that wishes to participate in the 2 Louisiana Catch and Cook Program shall apply to the Department of Wildlife 3 and Fisheries to be issued a participation permit by the department. There shall be no fee for the application process or permit. The permit may be suspended or revoked by the department for any violation of the rules and regulations of this program. The Department of Wildlife and Fisheries shall provide the 6 names and locations of each participating retail food establishment to the Department of Health and Hospitals, office of public health upon request.
