AN ACT

2	To enact Chapter 8-B of Title 46 of the Louisiana Revised Statutes of 1950, to be comprised
3	of R.S. 46:979.1 through 979.6, relative to the Louisiana First America Next
4	Freedom and Empowerment Act; to provide for the creation, implementation and
5	administration of the Louisiana First America Next Freedom and Empowerment
6	Plan; to provide for access to basic health insurance coverage for Louisiana citizens;
7	to provide for legislative findings and intent; to provide for application for certain
8	federal funds; to provide relative to funding and legislative oversight; to provide for
9	certain eligibility factors and reports; to provide relative to termination of the plan;
10	to provide certain terms, definitions, conditions and procedures; and to provide for
11	related matters.
12	Be it enacted by the Legislature of Louisiana:
13	Section 1. Chapter 8-B of Title 46 of the Louisiana Revised Statutes of 1950,
14	comprised of R.S. 46:979.1 through 979.6, is hereby enacted to read as follows:
15	CHAPTER 8-B. LOUISIANA FIRST AMERICA NEXT
16	FREEDOM AND EMPOWERMENT PLAN
17	<u>§979.1. Title</u>
18	This Chapter shall be known and may be cited as the "Louisiana First
19	America Next Freedom and Empowerment Act".
20	§979.2. Definitions
21	As used in this Chapter, the following terms shall have the following
22	definitions, unless the context clearly indicates otherwise:

1	(1) "Cost-sharing" means the portion of the cost of a covered medical
2	service that must be paid by or on behalf of eligible individuals, consisting of
3	copayments or coinsurance, but not deductibles.
4	(2) "Department" means the Department of Health and Hospitals.
5	(3) "Medicaid" means the medical assistance program provided for in
6	Title XIX of the Social Security Act.
7	(4) "Plan" means the Louisiana First America Next Freedom and
8	Empowerment Plan established by this Chapter.
9	(5) "Secretary" means the secretary of the Department of Health and
10	Hospitals.
11	§979.3. Legislative findings; purpose
12	A. The Legislature of Louisiana does hereby find and declare that, due
13	to compelling moral and economic reasons, Louisiana must enact positive
14	reforms to move the state's health care system in the right direction.
15	B. The Legislature of Louisiana does hereby find and declare that
16	Louisiana should expand access to affordable high quality health care. Our
17	state must create a solid safety net for the poorest of the poor and the sickest of
18	the sick. Louisiana must seek to offer to its citizens a health care system that
19	allows the patient to be in control, working with his own doctor and other health
20	care providers. Louisiana must work on reducing health care costs, since many
21	of Louisiana's citizens struggle to afford health care. Louisiana must work to
22	preserve and strengthen the safety net for the most vulnerable in our state,
23	including those with pre-existing conditions. Louisiana must focus on
24	enhancing patient choice, removing obstacles to portability, and promoting
25	consumer selection.
26	C. The Legislature of Louisiana does hereby find and declare that true
27	health reform puts doctors and patients, not government bureaucrats, at the
28	heart of all health policy decisions.
29	D. The purposes of this state in implementing the Louisiana First
30	America Next Freedom and Empowerment Plan are as follows:

1	(1) To lower health care costs by providing incentives for Louisiana
2	consumers to serve as smart health care shoppers, to save money by engaging
3	in healthy behaviors, and to take control of their health care choices.
4	(2) To protect the most vulnerable Louisiana citizens by targeting
5	government resources to those most at risk in our state and by enacting reforms
6	that would guarantee health care access to individuals with pre-existing
7	conditions, senior citizens, individuals with disabilities, and the unborn.
8	(3) To provide portability and choice to Louisiana consumers by offering
9	personalized choices so that consumers can buy the health care coverage plan
10	they want, not the plan a government bureaucrat tells them to purchase.
11	§979.4. Administration of the Louisiana First America Next Freedom and
12	Empowerment Plan
13	A. The Department of Health and Hospitals shall create and administer
14	the plan within the department. The department shall promulgate rules to
15	implement this Chapter in accordance with the Administrative Procedure Act.
16	B. In keeping with the plan's purposes set forth in R.S. 46:979.3, the
17	department shall on or before September 1, 2014, submit to the House and
18	Senate committees on health and welfare and to the governor an outline
19	specifying how it will seek to implement the following health care access reforms
20	in Louisiana beginning January 1, 2015:
21	(1) Lowering the cost of health care in Louisiana, including but not
22	limited to actions furthering the following goals:
23	(a) Tax equity: Giving all Louisiana consumers the same standard
24	deduction for health insurance, regardless of whether they obtain that health
25	insurance from an employer or on their own, and without raising taxes.
26	(b) A Louisiana health insurance program: Seeking any available
27	federal funds, including but not limited to the use of federal waivers or
28	Medicaid state plan amendments, so as to create an innovative and cost-effective
29	state health insurance program that would reduce health insurance premiums
30	to make coverage more affordable, guarantee access for individuals with pre-

existing conditions, and allow the state the option of using such funds to

2	subsidize health insurance coverage for individuals with pre-existing conditions
3	and low-income individuals who may not receive tax savings from a health
4	insurance deduction.
5	(c) Health savings accounts: Further increasing participation in the
6	plan's innovative insurance model and enhancing the ability to contain the
7	growth of health costs by allowing individuals to create personal health savings
8	accounts and use those funds to pay health insurance premiums, allowing for
9	additional flexibility in benefit design.
10	(d) Greater incentives for wellness: Providing insurers and employers
11	with additional flexibility to offer incentives for healthy behaviors, and the
12	ability to provide those incentives on a tax-free basis, in order to accelerate
13	efforts at changing behaviors in a way that can slow health cost growth.
14	(e) Focus on eliminating fraud: Moving away from the existing "pay
15	and chase" model of eliminating fraud, and seeking to target those who profit
16	from trafficking in personal health information.
17	(f) Price and quality transparency: Increasing online posting of health
18	care services price and quality data in order to empower Louisiana patients
19	with trusted information and provide Louisiana health care providers with a
20	greater incentive to improve their quality practices.
21	(2) Protecting the most vulnerable Louisiana citizens, including but not
22	limited to actions furthering the following goals:
23	(a) Guaranteed access for pre-existing conditions: Demonstrating in
24	requests to federal funding sources that, as a condition of participation in the
25	plan, Louisiana will guarantee access for individuals with pre-existing
26	conditions through a high-risk pool, reinsurance, or some other method
27	ensuring those with chronic conditions can obtain needed care.
28	(b) Premium support: Providing cost subsidies or premium assistance
29	so that Louisiana's senior citizens are offered more health insurance choices
30	while seeking to make Medicare more financially solvent and sustainable for

1	<u>future generations.</u>
2	(c) Medicaid reforms: Seeking to work with the federal government
3	through existing or new grant programs to demonstrate that, in exchange for
4	a fixed funding allotment from the federal government and accountability
5	standards, Louisiana will demonstrate flexibility in designing solutions to meet
6	the health care needs of Louisiana citizens.
7	(d) Life protections: Seeking to strengthen conscience protections for
8	businesses and medical providers.
9	(3) Portability and choice, including but not limited to actions furthering
10	the following goals:
11	(a) Louisiana-based reforms to expand access: Reforming laws that
12	govern medical licensure and construction of new medical facilities, in order to
13	increase the supply of medical providers, including new options that may lower
14	health care costs.
15	(b) Better access for individuals changing employers: Ending the
16	requirement that individuals leaving their employer must exhaust COBRA
17	continuation coverage before gaining access to the individual health insurance
18	market, in order to alleviate a costly mandate on businesses and ease the
19	transition into individual health coverage for those changing jobs.
20	(c) Pooling mechanisms: Allowing small businesses, fraternal
21	organizations, civic groups, alumni associations, and other similar organizations
22	to band together and offer health insurance to their members in order to
23	provide new options for individuals to purchase coverage that travels with them
24	from job to job.
25	(d) Cross-state insurance purchasing: Seeking to work with the federal
26	government and other state governments to allow purchasing of health
27	insurance across state lines, so as to allow Louisianians to buy the customized
28	health insurance plan that best meets their needs.
29	(e) Lawsuit reform: Enacting common sense reforms to crack down on

frivolous lawsuits in seeking to expand patient access and lower costs.

1	(f) Freedom for senior citizens to choose: Enhancing choice and
2	competition by eliminating the arbitrary restrictions on senior citizens' choice
3	of medical providers imposed by bureaucratic mandates, and seeking to restore
4	the doctor-patient relationship by working with the federal government to see
5	those onerous requirements repealed.
6	C. The department may work with any other state department in order
7	to seek to effect the plan's purposes, and shall do so with all deliberate speed so
8	as to effect these health care reforms in a timely manner.
9	D.(1) The department may utilize any federal or state funding, or any
10	other source of revenue, available to implement this plan.
11	(2) Prior to implementation, the department shall develop the plan,
12	including a determination of the cost, and submit the plan with the cost estimate
13	to the Joint Legislative Committee on the Budget for approval.
14	E. The plan may include premium support or insurance premium
15	subsidies for eligible individuals to enable their enrollment in a health insurance
16	<u>plan.</u>
17	F. The department shall be specifically authorized to pay supplemental
18	cost-sharing subsidies directly to health insurance plans or health savings
19	accounts for participants in the plan.
20	G. An eligible individual offered health insurance access, enrolled in
21	health insurance coverage or allowed to create a health savings account, shall
22	affirmatively acknowledge the existence of all of the following facts:
23	(1) The plan shall not be a perpetual federal or state right or guaranteed
24	entitlement.
25	(2) The plan shall be subject to cancellation upon appropriate notice.
26	(3) The plan shall not be an entitlement program.
27	H. The state may implement cost-sharing and copays, as a condition of
28	participation in the plan, for plan participants whose earning shall exceed fifty
28 29	participation in the plan, for plan participants whose earning shall exceed fifty percent of the applicable federal poverty level.

1	to the legislature. Adjustments shall be made by the legislature as appropriate.
2	J. On a quarterly basis, the department shall report to the Joint
3	Legislative Committee on the Budget, within two weeks of the end of each
4	quarter, information regarding the following aspects of the plan:
5	(1) Plan enrollment.
6	(2) Patient experience.
7	(3) Economic impact.
8	(4) Carrier competition.
9	(5) Success in avoiding uncompensated care.
10	§979.5. Plan outcomes; reporting requirements
11	A. On or before July 1, 2015, and annually thereafter, the secretary of
12	the department shall provide to the House and Senate committees on health and
13	welfare and to the governor a written report covering the most recent one-year
14	period which includes at a minimum all of the items required hereafter in this
15	Section.
16	B. The secretary shall make the report provided for in this Section
17	publicly available on its Internet website.
18	C. The report shall include but shall not be limited to the following
19	<u>items:</u>
20	(1) Evaluation of major barriers to access to health care by participants
21	in the Louisiana First America Next Freedom and Empowerment Plan, and
22	recommendations for policy changes to eliminate such barriers.
23	(2) Summary of successful initiatives in this state for disease prevention
24	and early diagnosis and management of chronic conditions among participants
25	in the plan.
26	(3) Such other information as the secretary deems appropriate to convey
27	a clear and sufficiently complete assessment of the impact of the plan.
28	§979.6. Termination
29	Annually during each regular session of the legislature, the legislature
30	shall have the authority to decide whether to continue the program.

Section 2. This Act shall become effective upon signature by the governor or, if not 2 signed by the governor, upon expiration of the time for bills to become law without signature 3 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana.
