APPROPRIATIONS/JUDGMENT: Appropriates funds for payment of judgment in the matter of "John Milton Munsen, et al. v. State of Louisiana DOTD"

1 AN ACT

2 To appropriate funds out of the General Fund of the state of Louisiana for Fiscal Year 2015-
3 2016 to be used to pay the consent judgment in the suit entitled "John Milton
4 Munsen on Behalf of his Minor Child, Emily Nicole Munsen; Dale Vaughn on
5 Behalf of his Minor Child Amanda Nichole Vaughn; and Milton Smith, Jr. on Behalf
6 of his Minor Child, Jaylin Telivia Boutte v. The Department of Transportation &
7 Development of/and the State of Louisiana; AT&T Inc., AT&T Corp., Bellsouth
8 Telecommunication, Inc. and AT&T Services Inc.; and Richard James Hickman";
9 and to provide for related matters.

10 Be it enacted by the Legislature of Louisiana:

11 Section 1. The sum of Five Thousand and No/100 (\$5,000.00) Dollars is hereby
12 appropriated out of the General Fund of the state of Louisiana for Fiscal Year 2015-2016 to
13 be used to pay the consent judgment in the suit entitled "John Milton Munsen on Behalf of
14 his Minor Child, Emily Nicole Munsen; Dale Vaughn on Behalf of his Minor Child Amanda
15 Nichole Vaughn; and Milton Smith, Jr. on Behalf of his Minor Child, Jaylin Telivia Boutte
16 v. The Department of Transportation & Development of/and the State of Louisiana; AT&T
17 Inc., AT&T Corp., Bellsouth Telecommunication, Inc. and AT&T Services Inc.; and Richard
18 James Hickman", bearing Number 118690-H on the docket of the 16th Judicial District
19 Court, parish of Iberia, state of Louisiana.

1 Section 2. This Act shall become effective on July 1, 2015; if vetoed by the governor
2 and subsequently approved by the legislature, this Act shall become effective on July 1,
3 2015, or on the day following such approval by the legislature, whichever is later.
