1	AN ACT
2	To enact Code of Civil Procedure Article 4733.1, relative to evictions; to provide for the
3	eviction of lessees from multifamily developments; to provide for definitions; and
4	to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. Code of Civil Procedure Article 4733.1 is hereby enacted to read as
7	follows:
8	Art. 4733.1. Eviction of lessees of multifamily developments
9	A. In addition to a judgment of eviction ordering a lessee or occupant to
10	deliver possession of the premises pursuant to Article 4732(B), and if the premises
11	is a unit of a multifamily development, the judgment of eviction and warrant for
12	possession shall extend to the entire multifamily development prohibiting the lessee
13	from occupying any unit of the multifamily development and authorizing the sheriff,
14	constable, or marshal to remove the lessee from the premises.
15	B. For purposes of this Article, "multifamily development" means any
16	building, including an apartment building, that is designed to house more than one
17	family and any group of mobile homes, as defined by R.S. 9:1149.2, located on a
18	tract of immovable property being managed or operated as a mobile home park.

Abstract: Extends the application of a judgment of eviction and warrant for possession to prohibit the lessee from occupying any unit of a multifamily development and to authorize the sheriff, constable, or marshal to remove the lessee from the premises.

<u>Present law</u> provides the procedures for obtaining a judgment of eviction and warrant for possession.

<u>Proposed law</u> extends the application of a judgment of eviction and warrant for possession, with respect to multifamily developments, to the entire multifamily development prohibiting the lessee from occupying any unit of the multifamily development and authorizing the sheriff, constable, or marshal to remove the lessee from the premises.

<u>Proposed law</u> defines "multifamily development" as any building, including an apartment building, that is designed to house more than one family and any group of mobile homes located on a tract of immovable property being managed or operated as a mobile home park.
