9 permanent living arrangement. The department shall document in the child's case
10 plan and its report to the court the compelling reason for recommending this plan
11 over the preceding higher priority alternatives.
12 (b) The permanent plan provided for in this Paragraph may be considered
13 only if the child is sixteen years of age or older."
