HEALTH SERVICES: Continues the Task Force on Art Therapist Licensure and Regulation

A CONCURRENT RESOLUTION

2	To continue the Task Force on Art Therapist Licensure and Regulation created in the 2014
3	Regular Session of the Legislature of Louisiana pursuant to House Concurrent
4	Resolution No. 159 for the purpose of studying the prospective establishment of art
5	therapist as a licensed profession, and to request that the task force report to the
6	legislative committees on health and welfare no later than sixty days prior to the
7	convening of the 2016 Regular Session with a baseline framework for licensure of
8	art therapists and regulation of the practice of art therapy.
9	WHEREAS, art therapy is a widely recognized and respected mental health
10	profession; and
11	WHEREAS, the profession of art therapy integrates psychotherapeutic principles,
12	art media, and the creative process for clinical mental health diagnosing, increasing
13	awareness of self and others, and promoting developmentally appropriate academic and
14	social interaction; and
15	WHEREAS, in the clinical realm, art therapy helps clients to achieve important
16	goals, including but not limited to the following:
17	(1) Coping with symptoms, stress, and traumatic experiences.
18	(2) Improving cognitive abilities.
19	(3) Addressing developmental, behavioral, mental, and emotional needs; and
20	WHEREAS, in Louisiana and elsewhere, art therapy is practiced in a wide variety
21	of settings, including hospitals, psychiatric and rehabilitation facilities, wellness centers,

2	clinical and community settings; and
3	WHEREAS, establishing the licensed profession of art therapist in Louisiana would
4	help to address unmet community needs for mental health services and would provide
5	important protections for the public, as full professional licensure, along with appropriate
6	standards and regulations for the profession, will ensure that only properly educated, trained,
7	and credentialed professionals are officially recognized as art therapists and are permitted,
8	exclusively, to use "art therapist" as a professional title in this state.
9	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
10	continue the Task Force on Art Therapist Licensure and Regulation to study the prospective
11	establishment of art therapist as a licensed profession in Louisiana.
12	BE IT FURTHER RESOLVED that the membership of the task force shall continue
13	as provided in House Concurrent Resolution No. 159 of the 2014 Regular Session of the
14	Legislature.
15	BE IT FURTHER RESOLVED that the task force shall reconvene on or before
16	October 1, 2015.
17	BE IT FURTHER RESOLVED that at its initial meeting pursuant to reconvening,
18	the task force members shall elect a chairperson, and shall adopt rules of procedure and any
19	other policies as may be necessary to facilitate the work of the group.
20	BE IT FURTHER RESOLVED that the task force shall submit a written report to the
21	House Committee on Health and Welfare and the Senate Committee on Health and Welfare
22	providing a baseline framework for licensure of art therapists and regulation of the practice
23	of art therapy no later than sixty days prior to the convening of the 2016 Regular Session of
24	the Legislature of Louisiana.
25	BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the
26	president of the Louisiana Art Therapy Association, the executive director of the Louisiana
27	Licensed Professional Counselors Board of Examiners, the president of the Louisiana
28	Association for Marriage and Family Therapy, the executive director of the Louisiana
29	Counseling Association, the state superintendent of education, the secretary of the
30	Department of Health and Hospitals, the executive director of the Louisiana State Board of
