14	WHEREAS, at its inception in 2007, Pilots for Patients began with five volunteer
15	pilots and has since grown to a listing of one hundred and five volunteer pilots; and
16	WHEREAS, pilots with this organization have flown more than two thousand two
17	hundred flights; and
18	WHEREAS, upon arrival at a medical treatment facility, Pilots for Patients are
