Adds a fee at license renewal for pharmacists and pharmacies and dedicates proceeds to certain pharmacy education

programs

<u>Proposed law</u> provides that in addition to any other fee authorized by <u>present law</u>, the Louisiana Board of Pharmacy (board) shall assess an additional fee of \$100 on annual renewals of pharmacist licenses and pharmacy permits; provides that the additional \$100 fee be designated as the "pharmacy education support fee"; requires the board to include on each license or permit renewal form issued to a pharmacist or pharmacy an option to not remit this additional fee; provides that all proceeds of the fee shall be dedicated and allocated to an accredited school of pharmacy at a public university in this state; requires that the board disburse all monies collected pursuant to <u>proposed law</u> to the public university pharmacy school on or before April 1 annually; requires that the university receiving the proceeds of the fee utilize the monies solely for the benefit of its pharmacy education program; provides that the expenditure of such funds shall be approved by the board of supervisors of the recipient university system; stipulates that funds collected shall be in addition to any other monies received by the university that operates the pharmacy school and that such funds are intended to supplement and not replace other funds.

## **EXPENDITURE EXPLANATION**

<u>Proposed law</u> allows pharmacists and pharmacies practicing or operating in the state of Louisiana to pay an additional \$100 fee on an annual basis as part of the license or permit renewal process respectively. <u>Although the fee is built into the fee schedule, an option to not remit the additional fee must be available on the renewal application.</u> The fee shall be dedicated and allocated to an accredited school of pharmacy of a public university in this state, of which one currently exists at the University of Louisiana, Monroe. The public university pharmacy school shall utilize these monies solely for the benefit of its pharmacy education program and the expenditure of such funds shall be approved by the board of supervisors of the corresponding university system.

The Board of Pharmacy reports that it can collect and process the proposed fee within its existing operating resources by requiring applicants to submit two separate checks at renewal (one for renewal and one for the education support fee).

## **REVENUE EXPLANATION**

Proposed law may increase revenues collected by the Louisiana Board of Pharmacy (board) by an indeterminable amount (not estimated to exceed \$960,000) for transfer to the state's singular existing School of Pharmacy at the University of Louisiana, Monroe. The LFO assumes these revenues would accrue as SGR to both the board and ULM.

Proposed law allows pharmacists and pharmacies practicing or operating in the state of Louisiana to pay an additional \$100 fee on an annual basis as part of the license or permit renewal process respectively. Although the fee is built into the fee schedule, an option to not remit the additional fee must be available on the renewal application. Proposed law is likely to result in an increase in revenues and expenditures but the LFO cannot quantify the percentage of renewals that will opt out of making the additional payment in any given fiscal year.

NOTE: There are currently approximately 7,700 licensed pharmacists in the state of Louisiana and 1,900 pharmacies. Each renewal that includes the new \$100 "pharmacy education support fee" will result in an incremental increase in expenditures for the School of Pharmacy at ULM. If all eligible renewals included the optional educational support fee, the maximum potential increase in expenditures would be \$960,000 (7,700 pharmacists + 1,900 pharmacies x \$100 = \$960,000). The total collections are likely to fall short of this number on a basis of \$100 per pharmacist or pharmacy opt out.
