2 On page 9, at the beginning of line 15, insert "A."

3 AMENDMENT NO. 11

4 On page 9, between lines 21 and 22, insert the following:

5 "B. Service by electronic mail is complete upon transmission but is not  
6 effective if the serving party learns the transmission did not reach the party to be  
7 served."

8 AMENDMENT NO. 12

9 On page 11, delete lines 2 through 5 and insert in lieu thereof the following:

10 "(5)(a) Placement in the least restrictive, most family-like alternative  
11 permanent living arrangement. The department shall document in the child's case  
12 plan and its report to the court the compelling reason for recommending this plan  
13 over the preceding higher priority alternatives.

14 (b) The permanent plan provided for in this Paragraph may be considered  
15 only if the child is sixteen years of age or older."

16 AMENDMENT NO. 13

17 On page 13, at the beginning of line 28, insert "A."

18 AMENDMENT NO. 14

19 On page 14, between lines 9 and 10, insert the following:

20 "B. Service by electronic mail is complete upon transmission but is not  
21 effective if the serving party learns the transmission did not reach the party to be  
22 served."

23 AMENDMENT NO. 15

24 On page 14, at the beginning of line 12, insert "A."

25 AMENDMENT NO. 16

26 On page 14, between lines 22 and 23, insert the following:

27 "B. Service by electronic mail is complete upon transmission but is not  
28 effective if the serving party learns the transmission did not reach the party to be  
29 served."

30 AMENDMENT NO. 17

31 On page 15, line 20, after "cultural," and before "activities" delete "and social" and insert in  
32 lieu thereof "social, and sporting"
