Amendments proposed by Senator Morrish to Engrossed Senate Bill No. 172 by Senator Morrish

1 AMENDMENT NO. 1

2 On page 3, line 25, delete "**or a person providing items to be transported,**"

3 AMENDMENT NO. 2

4 On page 3, line 28, delete "**or items to be transported,**"

5 AMENDMENT NO. 3

6 On page 3, line 29, delete "**or the item to be transported is removed**"

7 AMENDMENT NO. 4

8 On page page 4, line 10, delete "**or persons providing items for transport**"

9 AMENDMENT NO. 5

10 On page 4, at the end of line 14, insert:

11 **""Transportation network company" shall include the person, whether natural**  
12 **or juridical, that contracts with the transportation network company driver and the**  
13 **person, whether natural or juridical, that contracts with the person requesting a ride**  
14 **through the digital network."**

15 AMENDMENT NO. 6

16 On page 4, lines 16 and 17, delete "**or providers of items to be transported**"

17 AMENDMENT NO. 7

18 On page 4, line 25, delete "**""Rider" also**" and delete lines 26 through 29

19 AMENDMENT NO. 8

20 On page 5, line 1, delete "**with drivers**" and at the end of line 1 insert "**; choice of law and**  
21 **forum**"

22 AMENDMENT NO. 9

23 On page 5, delete lines 15 through 18 and on line 19, change "**C.**" to "**B.**"

24 AMENDMENT NO. 10

25 On page 5, after line 22, insert:

26 **"C. All legal issues and disputes relating to a transportation network company's**  
27 **operation pursuant to this Part or the providing of transportation network**  
28 **company services pursuant to this Part, by and among a transportation network**  
29 **company, a transportation network company driver, and a person requesting**  
30 **a ride through a digital network, or other third parties shall be exclusively**  
31 **conducted in a court of competent jurisdiction in the state of Louisiana. All**  
32 **choice of law conflicts shall be resolved in accordance with Louisiana law."**

1 AMENDMENT NO. 11

2 On page 6, lines 8 and 9, delete "**in the amount of not less than one million dollars.**" and  
3 insert "**to the extent required by R.S. 22:1295.**"

4 AMENDMENT NO. 12

5 On page 7, line 3, delete "**or items**"

6 AMENDMENT NO. 13

7 On page 8, line 5, delete "**or items**"

8 AMENDMENT NO. 14

9 On page 8, line 28, change "**fourteen**" to "**ten business**"

10 AMENDMENT NO. 15

11 On page 9, delete lines 11 through 19, and insert:

12 **"A transportation network company driver shall carry written or digital**  
13 **proof of coverage satisfying R.S. 45:201.6 with him at all times during his use**  
14 **of a vehicle in connection with a transportation network company's digital**  
15 **network. In the event of an accident, a transportation network company driver**  
16 **shall provide this insurance coverage information to the directly interested**  
17 **parties, automobile insurers, and investigating police officers, upon request**  
18 **pursuant to R.S. 32:862. Upon such request, a transportation network company**  
19 **driver shall also disclose to directly interested parties, automobile insurers, and**  
20 **investigating police officers, whether he was logged on to the transportation**  
21 **network company's digital network or on a prearranged ride at the time of an**  
22 **accident.**"
