6	(5) A motion picture production company applying for the additional credit
7	for the employment of Louisiana residents must remit a schedule to the Department
8	of Revenue, in a machine-sensible format approved by the secretary of the

10	persons who received salary, wages, or other compensation for services performed
11	in Louisiana in connection with the state-certified production, and the address,
12	taxpayer identification number, permanent address of, and the amount of

18	Section 2. This Act shall become effective on July 1, 2015; if vetoed by the governor
19	and subsequently approved by the legislature, this Act shall become effective on July 1,

SB 101 Reengrossed

<u>Present law</u> grants a motion picture investor tax credit as a percentage of the "base investment" made and used for "production expenditures" in the state for a "state-certified production". The term "production expenditures" includes "payroll" defined as all salary, wages, and other compensation, including benefits paid to an employee for services relating to a state-certified production and taxable in this state. An additional credit of 5% is allowed for the employment of Louisiana residents.

<u>Proposed law</u> requires the office of entertainment industry development in the Department of Economic Development and the Department of Revenue to verify such payroll through the use of information which must be provided to them by the Louisiana Workforce
