**EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure. The Legislative Fiscal Office attempt to reach an existing contact for the Allen Parish Reservoir District was unsuccessful. An attempt to contact the West Ouachita Parish Reservoir District was also unsuccessful, and as a result LFO considers the district inactive.

The Legislative Auditor currently considers the Governing Board of the Jean Lafitte Marine Fisheries Museum inactive. The South Louisiana Wetlands Discovery Center Commission is currently listed as inactive on the Division of Administration's database of boards and commissions.

**REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure. However, in the event any of these boards have available funds, they will be remitted to the state general fund.
