6	to remove requirement that members of the board of commissioners be from certain
7	areas; to provide for a definition of a quorum; to provide for an effective date; and

12	Be it enacted by the Legislature of Louisiana:
13	Section 1. R.S. 38:291(T)(2)(a)(introductory paragraph) and (i), (b), and (c) and (4)
14	are hereby amended and reenacted and R.S. 38:291(T)(2)(d) is hereby enacted to read as

(b) The term of office of any commissioner appointed pursuant to 7 8 Subparagraph (a) of this Paragraph shall cease in January 2008, or thereafter, when 9 his successor is appointed and takes office. Beginning in January 2008, and 10 thereafter, the governor shall appoint a board of commissioners consisting of nine 11 persons, subject to Senate confirmation. Such membership shall be comprised of no 12 fewer than three members from the area within the district lying to the east of Bayou 13 Lafourche, no fewer than three members from the area within the district lying to the west of Bayou Lafourche, and the remaining members from the district at-large, all 14 15 appointed pursuant to the list of nominations submitted to the governor by the 16 nominating parties as provided in Subparagraph (a) of this Paragraph.

(c) In the event nine all commissioners are not appointed within sixty days
of the beginning of the term or a vacancy pursuant to the foregoing the occurrence
of a vacancy, then another list of nominations selected by a majority of the members
of the legislature representing the district shall be submitted, and the governor shall
appoint the remaining required commissioner or commissioners from the list to bring
the total number of commissioners to nine to provide for the total number of
commissioners required by Subparagraph (a) of this Paragraph.
