Amendments proposed by Representative Smith to Engrossed House Bill No. 823 by Representative Barrow

1 AMENDMENT NO. 1

2 On page 1, line 2, after "R.S. 33:2740.67(A)" and before the comma "," delete "and (B)" and
3 insert "(B), and (C)(1) and (2)"

4 AMENDMENT NO. 2

5 On page 1, line 4, after "district;" and before "and" insert "to provide for the membership of
6 the board;"

7 AMENDMENT NO. 3

8 On page 1, line 9, after "R.S. 33:2740.67(A)" and before "are" delete "and (B)" and insert
9 ", (B), and (C)(1) and (2)"

10 AMENDMENT NO. 4

11 On page 2, between lines 17 and 18, insert the following:

12 "C. Governance. (1) In order to provide for the orderly planning,
13 development, acquisition, construction, and effectuation of the services,
14 improvements, and facilities to be furnished by the district and to provide for the
15 representation in the affairs of the district of those persons and interests immediately
16 concerned with and affected by the purposes and development of the district, the
17 district shall be managed by a ~~nine-member~~ thirteen-member board of
18 commissioners, referred to in this Section as the "board". The board shall be
19 comprised of members as follows:

20 (a) Two members shall be appointed by the state representative for House
21 District No. 29, one of whom shall be a representative of the business community.

22 (b) Two members shall be appointed by the state senator for Senate District
23 No. 15.

24 (c) One member shall be appointed by the mayor-president of the parish of
25 East Baton Rouge.

26 (d) One member shall be appointed by the member or members of the
27 governing authority of the parish of East Baton Rouge who represent the district.

28 (e) One member shall be appointed by the owner of the largest parcel of land
29 located within the district.

30 (f) One member shall be appointed by the state representative for House
31 District No. 61.

1 (g) One member shall be appointed by the state representative for House
2 District No. 67.

3 (h) One member shall be appointed by the state representative for House
4 District No. 101.

5 (i) One member shall be appointed by the state senator for Senate District
6 No. 14.

7 ~~(f)~~ (j) The branch manager of a bank located within the district to be selected
8 by a subcommittee formed by the board.

9 ~~(g)~~ (k) One representative of a civic association located within the district
10 to be selected by a subcommittee formed by the board.

11 (2)(a)(i) Members serving pursuant to Subparagraphs (1)(a) through ~~(e)~~ (i)
12 of this Subsection shall serve four-year terms after initial terms as provided by Item
13 (ii) of this Subparagraph.

14 (ii) ~~Two~~ Three members shall serve an initial term of one year; ~~two~~ three
15 shall serve two years; ~~two~~ three shall serve three years; and ~~one~~ two shall serve four
16 years, as determined by lot at the first meeting of the board.

17 (b) Members serving pursuant to Subparagraphs ~~(1)(f)~~ and ~~(g)~~ (1)(j) and (k)
18 of this Subsection shall serve at the pleasure of the subcommittee formed by the
19 board."
