Changes permitted uses of monies in the St. James Parish Enterprise Fund

Current law defines permitted uses of the St. James Parish Enterprise Fund as land acquisition, building construction related to the St. James Convention Facility, agricultural arena, or farmer's market.

Proposed law retains current law and authorizes the governing authority of St. James Parish to also use the St. James Parish Enterprise Fund to promote tourism and economic development as well as for maintenance, repair and parking for the St. James Convention Facility or the St. James Parish Tourist Information Welcome Center.

**EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure.

**REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure. According to the Department of Revenue, approximately \$21,000 was deposited to the St. James Parish Enterprise Fund in FY 14, which is the dedication of 2.97% of the state sales tax rate on hotel/motel rentals generated in the parish.

The bill expands permitted uses of the St. James Parish Enterprise Fund by including tourism and economic development along with maintenance and repair of buildings and parking associated with the St. James Convention Facility or the St. James Parish Tourist Information Welcome Center.
