Provides relative to downtown traffic control in the city of New Orleans

Purpose of Bill: This bill authorizes the Superintendent of Police in the City of New Orleans and Orleans Parish to employ traffic control officers within certain geographic boundaries of the city and parish in order to direct, control and regulate traffic. However, such officers shall not have the authority to issue traffic citations.
