2 On page 2, line 11, after "**The**" delete "**chair**" and insert "**executive director**"

4 On page 2, delete lines 12 through 16, and insert:

5 **"(2) Three members representing the Department of Children and Family**  
 6 **Services appointed by the secretary of the department, one of whom shall be a**  
 7 **representative of the kinship care subsidy program, one of whom shall be a**  
 8 **representative of the food stamp program, and one of whom shall be a**  
 9 **representative of the foster care program.**

10 **(3) Two members representing the Department of Health and Hospitals**  
 11 **appointed by the secretary of the department, one of whom shall be a**  
 12 **representative of the behavioral health program, and one of whom shall be a**  
 13 **representative of the Medicaid eligibility program.**

14 **(4) A member representing the Department of Education appointed by the**  
 15 **superintendent, who shall be a representative of the child care assistance**  
 16 **program."**
