REGISTRARS OF VOTERS: Provides qualifications for the office of registrar of voters

AN ACT

2	To amend and reenact R.S. 18:52, relative to the office of registrar of voters; to provide
3	qualifications for registrars of voters and applicants for the office of registrar of
4	voters; to provide definitions; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 18:52 is hereby amended and reenacted to read as follows:
7	§52. Qualification Qualifications of registrars
8	A. Each applicant to fill the office of registrar of voters shall be a registered
9	voter. If appointed to fill the office of registrar of voters, the applicant shall become
10	a resident and registered voter of the parish in which he is to perform his duties prior
11	to taking the oath of office. Each The registrar shall be remain a resident and
12	qualified voter of the parish in which he is to perform his duties.
13	B.(1) The registrar shall possess at least one of the following at the time of
14	appointment:
15	(a) A baccalaureate degree and three years of full-time, professional work
16	experience.
17	(b) Nine years of full-time, professional work experience.
18	(c) Six years of full-time employment in a registrar's office in Louisiana.
19	(2) For purposes of this Subsection, "professional work experience" means
20	experience in an occupation which requires specialized and theoretical knowledge

Abstract: Provides qualifications for registrars of voters.

<u>Present constitution</u> (Art. XI, §5) provides that the governing authority of each parish shall appoint a registrar of voters, whose compensation, removal from office for cause, bond, powers, and functions shall be provided by law.

<u>Present law</u> (R.S. 18:52) requires the registrar to be a resident and qualified voter of the parish in which he is to perform his duties.

Proposed law retains present law.

<u>Proposed law</u> additionally requires each applicant to fill the office of registrar of voters to be a registered voter. Provides that if appointed to fill the office of registrar of voters, the applicant shall become a resident and registered voter of the parish in which he is to perform his duties prior to taking the oath of office.

<u>Proposed law</u> requires the registrar to possess at least one of the following at the time of appointment:

- (1) A baccalaureate degree and three years of full-time, professional work experience.
- (2) Nine years of full-time, professional work experience.
- (3) Six years of full-time employment in a registrar's office in La.

Provides that for purposes of <u>proposed law</u>, "professional work experience" means experience in an occupation which requires specialized and theoretical knowledge usually acquired through college training or through work experience and other training which provides comparable knowledge.

<u>Proposed law</u> provides that it does not apply to any registrar appointed prior to the effective date of proposed law.
