STATE DEPARTMENTS: Requires the Dept. of Health and Hospitals and Dept. of Children and Family Services to report to the legislature information concerning administration of the departments

AN ACT

2	To enact R.S. 36:254(A)(15) and 474(A)(13), relative to reporting of information to the
3	legislature concerning the administration of certain state departments; to provide for
4	duties of the secretary of the Department of Health and Hospitals and the secretary
5	of the Department of Children and Family Services; to require the secretaries of
6	these departments to report to the legislature certain information concerning
7	departmental organization and staff salaries; to specify the period for reporting of
8	such information; and to provide for related matters.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. R.S. 36:254(A)(15) and 474(A)(13) are hereby enacted to read as follows:
11	§254. Powers and duties of the secretary of the Department of Health and Hospitals
12	A. In addition to the functions, powers, and duties otherwise vested in the
13	secretary by law, he shall:

15	(15)(a) On an annual basis, provide all of the following information to the
16	legislature no later than thirty days prior to the convening of each Regular Session:

Abstract: Requires the secretaries of the Dept. of Health and Hospitals and Dept. of Children and Family Services to report to the legislature information concerning organization and staff salaries of the respective departments.

Proposed law requires that on an annual basis, the secretaries of the Dept. of Health and Hospitals and Dept. of Children and Family Services shall provide all of the following information to the legislature concerning the departments, respectively:

(1) A full organizational chart for the department which is current as of the date of submission and which shows each staff position, whether filled or vacant, that comprises the department.

(2) The current salary of the person occupying each filled position shown on the organizational chart.

<u>Proposed law</u> requires the secretaries of the two departments to report this information to the legislature no later than 30 days prior to the convening of each Regular Session.

<u>Proposed law</u> authorizes the secretaries of the two departments to include the report required by <u>proposed law</u> with submissions of the annual reports to the legislature relative to general operations of the departments required by present law.
