2	To amend and reenact R.S. 23:534(1) and 540, relative to regulations affecting boilers; to
3	provide with respect to compensation of certain inspectors; to exempt certain potable
4	water boilers; to provide for technical corrections; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 23:534(1) and 540 are hereby amended and reenacted to read as

8	§534. Duties of assistant secretary
9	The assistant secretary shall:
10	(1) Employ and compensate, with the approval of the governor, inspectors
11	and other assistants and employees as he may deem necessary for the exercise of the
12	powers and the performance of the duties prescribed in this Part. <u>Inspectors</u>
13	employed and compensated pursuant to the provisions of this Section shall be
14	compensated commensurate with the compensation paid to similarly situated
15	inspectors in the private sector in the state of Louisiana.

Abstract: Requires certain compensation for boiler inspectors and exempts potable water boilers below 120 gallon capacity and less than 200,000 BTUs (British Thermal Units) from regulations affecting boilers.

<u>Present law</u> (R.S. 23:531 et seq.) provides for regulations affecting boilers. <u>Proposed law</u> retains <u>present law</u>.

<u>Present law</u> (R.S. 23:534) authorizes the assistant secretary to employ and compensate inspectors and other assistants and employees as he deems necessary for the exercise of powers and performance of duties as described in <u>present law</u> and <u>proposed law</u>. <u>Proposed law</u> retains <u>present law</u> and requires employed and compensated inspectors to be compensated commensurate with the compensation paid to similarly situated inspectors in the private sector in the state of La.

Present law (R.S. 23:540) exempts certain boilers from regulations affecting boilers.

<u>Proposed law</u> adds potable water boilers below 120 gallon capacity and less than 200,000 BTUs (British Thermal Units) to the exemptions. Further makes technical changes and otherwise retains <u>present law</u> (R.S. 23:540).
