2	To amend and reenact R.S. 40:964 (Schedule II)(A)(1)(introductory paragraph) and (4) and
3	to enact R.S. 40:964(Schedule IV)(E)(3), relative to the Uniform Controlled
4	Dangerous Substances Law; to add certain substances to Schedules II and IV; and
5	to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 40:964 (Schedule II)(A)(1)(introductory paragraph) and (4) are
8	hereby amended and reenacted and R.S. $40:964$ (Schedule IV)(E)(3) is hereby enacted to read
9	as follows:
10	§964. Composition of schedules
11	Schedules I, II, III, IV, and V shall, unless and until added to pursuant to R.S.
12	40:962, consist of the following drugs or other substances, by whatever official
13	name, common or usual name, chemical name, or brand name designated:

16	A. Substances of vegetable origin or chemical synthesis. Unless specifically
17	excepted or unless listed in another schedule, any of the following substances
18	whether produced directly or indirectly by extraction from substances of vegetable
19	origin, or independently by means of chemical synthesis, or by a combination of
20	extraction and chemical synthesis:
21	(1) Opium and opiate, and any salt, compound, isomer, derivative, or
22	preparation of opium or opiate, excluding apomorphine, thebaine-derived
23	butorphanol, dextrorphan, nalbuphine, nalmefene, naloxegol, naloxone, and
24	naltrexone, and their respective salts, but including the following:
