Provides relative to the capital outlay budget submission.

The proposed legislation requires the application for any capital outlay (CO) budget request which receives funding in the CO budget shall be updated each year that the project remains active in the budget process. The resubmission of the CO budget request shall be subject to all of the requirements and deadline as all other CO budget requests. It further requires the detailed project description and justification shall include the estimated local match requirement and the amount of local funds expended on the project. The detailed project description for all statewide programs shall included specific information and details of the projects qualifying for funding through the programs proposed to be funded with the appropriations included in the CO budget. Any project receiving an individual appropriation shall submit a capital outlay application by the November 1st deadline regardless if the project is eligible for funding through a statewide program. The Office of Facility Planning & Control (FP&C) and any state agency authorized to administer CO appropriations shall submit an annual written report with specific information of each project included in the prior year's CO budget no later than February 1st.
