ENVIRONMENT QUALITY DEPT. Requests the Department of Environmental Quality to study the removal of certain Reid vapor pressure requirements in certain parishes.

1	A CONCURRENT RESOLUTION
2	To urge and request the Department of Environmental Quality to study the removal of Reid
3	vapor pressure gasoline requirements in Ascension, Beauregard, Calcasieu, East
4	Baton Rouge, Iberville, Jefferson, Lafayette, Lafourche, Livingston, Orleans, Pointe
5	Coupee, St. Bernard, St. Charles, St. James, St. Mary, and West Baton Rouge
6	parishes.
7	WHEREAS, a healthy atmosphere with clean air is an indisputable concern for our
8	world, our nation, and our state; and
9	WHEREAS, emissions caused by the volatility of gasoline has been thought to be
10	a contributing factor in the deterioration of the ozone; and
11	WHEREAS, Reid vapor pressure is a common measure of and generic term for this
12	gasoline volatility; and
13	WHEREAS, current law requires the United States Environmental Protection Agency
14	to set a maximum gasoline Reid vapor pressure (RVP) standard of 9.0 pounds per square
15	inch from June 1st to September 15th of each year but allows a more stringent standard of
16	7.8 pounds per square inch in areas that do not qualify as having reached ozone attainment
17	requirements; and
18	WHEREAS, currently in Louisiana this special RVP requirement is enforced in

Ascension, Beauregard, Calcasieu, East Baton Rouge, Iberville, Jefferson, Lafayette, 1 2 Lafourche, Livingston, Orleans, Pointe Coupee, St. Bernard, St. Charles, St. James, St. 3 Mary, and West Baton Rouge parishes; and WHEREAS, recent scientific data is proving that the reduced RVP has little to no 4 5 impact on the quality of the air and ozone; and 6 WHEREAS, these lower standards are a burden on manufacturing special blends of 7 gasoline, thus costing the consumer more for fuel and thus hurting the economy. 8 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby 9 request the Department of Environmental Quality study the removal of the lower summer 10 Reid vapor pressure requirements in Ascension, Beauregard, Calcasieu, East Baton Rouge, 11 Iberville, Jefferson, Lafayette, Lafourche, Livingston, Orleans, Pointe Coupee, St. Bernard, 12 St. Charles, St. James, St. Mary, and West Baton Rouge parishes. 13 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the 14 secretary of the Department of Environmental Quality.
