<u>Present law</u> provides for a commercial facility reuse material application fee of \$300. Proposed law reduces the fee to \$100. Present law provides for an authorization for after-hours disposal of exploration and production waste fee of \$150. Proposed law repeals the fee.

EXPENDITURE EXPLANATION

<u>Proposed law</u> reduces fees associated with existing expenditures of the Department of Natural Resources. To the extent these activities cannot be offset by other revenue sources, there may be an expenditure impact for the department.

REVENUE EXPLANATION

DNR projects a reduction of approximately \$58,750 per year in the Statutory Dedications - Oil and Gas Regulatory Fund due to the fee reductions in proposed law. Proposed law reduces the commercial facility reuse material application fee by \$200 (from \$300 in present law to \$100). DNR projects a \$10,000 revenue reduction resulting from 50 applications multiplied by the \$200 fee reduction. Proposed law repeals the authorization for after-hours disposal of exploration and production waste fee of \$150. DNR projects 325 of these applications, resulting in a revenue decrease of approximately \$48,750 (325 X \$150).
