HOUSE CONCURRENT RESOLUTION NO. 118

ENVIRONMENT/AIR: Provides for environmental study of conditions present when munitions are burned for destruction

1	A CONCURRENT RESOLUTION
2	To direct the Department of Environmental Quality to conduct environmental testing on the
3	conditions present when munitions are disposed of by the process of open burning
4	and open detonation, report results, and form a dialogue committee.
5	WHEREAS, citizens of the state of Louisiana have expressed concerns over
6	environmental conditions brought about by the process of disposal of munitions by open
7	burning and open detonation; and
8	WHEREAS, the state of Louisiana, in partnership with the United States
9	Environmental Protection Agency, is currently engaged in the largest disposal project in the
10	United States for expired munitions at the Camp Minden Louisiana National Guard facility;
11	and
12	WHEREAS, the state of Louisiana currently has permitted a commercial facility for
13	the open burning and open detonation of explosives; and
14	WHEREAS, the Department of Environmental Quality is the appropriate agency to
15	conduct an investigation of environmental soil, ground water, and air conditions resulting
16	from the open burning and open detonation of munitions; and
17	WHEREAS, the citizens of the state of Louisiana have asked that the Department of
18	Environmental Quality conduct soil, ground water, and air sampling at the commercial open
19	burning and open detonation facility.
20	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
21	direct the Department of Environmental Quality to develop and implement a sampling plan

4 BE IT FURTHER RESOLVED the Department of Environmental Quality shall complete the sampling plan, sampling, and analysis of the results within six months of the 5 6 adoption of this Resolution and report the results of that sampling to the House Committee on Natural Resources and Environment and the Senate Committee on Environmental 7 8 Quality. 9 BE IT FURTHER RESOLVED that within thirty days of the adoption of this 10 Resolution, the Department of Environmental Quality shall collaborate with Clean Harbors 11 Colfax, LLC on the formation of a dialogue committee with regard to all site activities. 12 BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted 13 to the secretary of the Department of Environmental Quality and to Clean Harbors Colfax,

14 LLC.

Reynolds

Directs the Dept. of Environmental Quality to develop and implement a sampling plan for testing certain commercial open burn and open detonate facilities and report results to the oversight committees within six months.

Requires the Dept. of Environmental Quality and Clean Harbors Colfax, LLC to form a dialogue committee within 30 days of the adoption of this Resolution.

Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Natural Resources and</u> <u>Environment</u> to the <u>original</u> bill:

1. Specify that the sampling plan applies to "commercial" facilities.
