HOUSE CONCURRENT RESOLUTION NO. 117

LAW ENFORCE/OFFICERS: Creates a task force to study and make recommendations for law enforcement officers involved in certain incidents

1	A CONCURRENT RESOLUTION
2	To create the Louisiana Law Enforcement Officer-Involved Incident Task Force to study
3	and make recommendations regarding the implementation and development of
4	guidelines for investigating officer-involved incidents by law enforcement agencies
5	in this state, and to provide for a written report of its recommendations and findings
6	no later than sixty days prior to the 2017 Regular Session of the Louisiana
7	Legislature.
8	WHEREAS, in order to safeguard the public and law enforcement officers of this
9	state, it is vital for law enforcement officers and the communities that they serve to have
10	strong, collaborative relationships; and
11	WHEREAS, trust between law enforcement officers and the public is essential to the
12	stability of communities, the integrity of the criminal justice system, and the safe and
13	effective delivery of public safety services; and
14	WHEREAS, every precaution must be taken to ensure that the duties of law
15	enforcement officers are performed at the highest level available; and
16	WHEREAS, it is essential for law enforcement officers to demonstrate accountability
17	to the community through an impartial, transparent, timely, and systematic investigative
18	process; and
19	WHEREAS, an "officer-involved incident" means any incident which the death of
20	another individual is caused by a law enforcement officer acting under the authority of the
21	state or a political subdivision of the state; and

1	WHEREAS, investigations pertaining to officer-involved incidents are frequently
2	more complex and demanding than other incidents involving law enforcement officers; and
3	WHEREAS, questions arise about the propriety of a law enforcement agency
4	conducting an investigation wherein one of its own officers is involved; and
5	WHEREAS, officer-involved incidents should be performed in a manner that
6	provides for a thorough and credible investigation free from conflicts; and
7	WHEREAS, investigations of officer-involved incidents should commence as
8	promptly as practicable after the occurrence; and
9	WHEREAS, investigations of officer-involved incidents may uncover deficiencies
10	that lead to necessary changes in policy, training, and legislation.
11	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
12	create the Louisiana Law Enforcement Officer-Involved Incident Task Force to study and
13	make recommendations regarding the efficiency and timeliness of investigations pertaining
14	to officer-involved incidents.
15	BE IT FURTHER RESOLVED that this task force shall consist of nineteen members
16	and be composed of the following:
17	(1) The chair of the House Committee on Judiciary.
18	(2) The chair of the Senate Committee on Judiciary B.
19	(3) The attorney general or his designee.
20	(4) The state public defender or his designee.
21	(5) The president of the Louisiana District Attorney's Association or his designee.
22	(6) The executive director of the Louisiana Sheriff's Association or his designee.
23	(7) The president of the Louisiana Association of Chiefs of Police or his designee.
24	(8) The president of the Louisiana Fraternal Order of Police or his designee.
25	(9) A representative of the American Civil Liberties Union of Louisiana.
26	(10) A district court judge designated by the chief justice of the Louisiana Supreme
27	Court.
28	(11) A representative of the Louisiana State University Police Department.
29	(12) A representative of the Southern University Police Department.

1	(13) A representative of the National Association of the Advancement of Colored
2	People.
3	(14) A member of the Louisiana House of Representatives representing district
4	seventeen or his designee.
5	(15) A mayor or city-parish president representing an urban municipality as
6	designated by the Louisiana Municipal Association.
7	(16) A mayor or city-parish president representing a suburban municipality as
8	designated by the Louisiana Municipal Association.
9	(17) The superintendent of Louisiana State Police or his designee.
10	(18) The president of the Louisiana Association of Broadcasters or his designee.
11	(19) The president of the Louisiana Press Association or his designee.
12	BE IT FURTHER RESOLVED that all appointments to the task force shall be made
13	within thirty days after adjournment of this legislature in the 2016 Regular Session.
14	Vacancies shall be filled in the same manner as the original appointments. The members of
15	the task force shall serve without compensation.
16	BE IT FURTHER RESOLVED that a majority of the membership of the task force
17	shall constitute a quorum and shall elect the chair of the task force at its first meeting. The
18	task force shall meet at the call of the chair or upon an affirmative vote of a majority of the
19	task force. All members must be notified in writing of all meetings at least five days before
20	the date on which a meeting of the task force is scheduled.
21	BE IT FURTHER RESOLVED that the chair shall call an initial meeting of the task
22	force no later than October 1, 2016, and hold meetings at the times and in the places it may
23	deem appropriate and necessary to fulfill its charge. The task force may avail itself of the
24	services of the employees of any state or municipal department, agency, or board as it may
25	require and as may be available to it for its purposes.
26	BE IT FURTHER RESOLVED that the task force shall meet no less than two times.
27	BE IT FURTHER RESOLVED that the task force may seek the advice of experts as
28	deemed appropriate by the membership of the task force.
29	BE IT FURTHER RESOLVED that the task force shall prepare and submit a final
30	report that contains a detailed statement of the findings and policy recommendations of the

1 task force to the governor, the president of the Senate, the speaker of the House of

- 2 Representatives, the chairman of the House Committee on Judiciary, the chairman of the
- 3 Senate Committee on Judiciary B, and the chief justice of the Louisiana Supreme Court not
- 4 later than sixty days prior to the beginning of the 2017 Regular Session of the Legislature
- 5 of Louisiana and that such recommendations shall include but not be limited to the
- 6 following:
- 7 (1) General guidelines to ensure that officer-involved incidents are thoroughly,
- 8 fairly, and timely investigated.
- 9 (2) General guidelines to ensure that proper dispositions of officer-involved
- incidents are based upon all legally available and relevant evidence.
- 11 (3) Legislation needed, if any, to provide for new protocols for investigations related
- 12 to officer-involved incidents.
- BE IT FURTHER RESOLVED that the task force shall be abolished upon
- submission of the report.
- BE IT FURTHER RESOLVED that copies of this Resolution be transmitted to the
- 16 appointing entities named in this Resolution.
