<u>Proposed law</u> revises present law by replacing the two nonvoting physician members of the board with two consumer representatives from the state at-large appointed by the governor, neither of whom shall be a nurse, who shall be voting

members. Proposed law revises present law by requiring a board member to be a certified registered nurse anesthetist.

Proposed law requires that each consumer representative member possess the following qualifications:

(1) Has attained the age of majority. (2) Does not engage in and never has engaged in any activity directly related to the practice of nursing. (3) Has never been convicted of a felony. (4) Is a US Citizen that has been a Louisiana resident for at least one year.

<u>Present law</u> requires the board to establish reasonable fees for issuance and renewal of licenses and permits, and provides that such fees shall not exceed \$100. <u>Proposed law</u> requires fees to not exceed \$100 per <u>calendar year</u>.

EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of this measure.

REVENUE EXPLANATION

This measure is not anticipated to impact the Board of Nursing's fees and self-generated revenues. The Board of Nursing currently has annual nursing fees for registration and licensure that are renewed between October and December with an effective begin date of January 1.

This measure clarifies that these fees cannot exceed \$100 per calendar year (January through December). The Board of Nursing currently does not have any fees exceeding \$100 per calendar year therefore this measure is not anticipated to impact revenues.
