If the person has elected not to apply for a REAL ID compliant 34 driver's license, the department shall not require the applicant to comply with 35 36 any REAL ID requirements that were not required by the state as of January 37 1, 2016, or require the applicant to submit to a facial image capture in connection with such application prior to determining if such applicant is 38 39 eligible to be issued a driver's license pursuant to the provisions of this Chapter.
