 7 A CERTAIN PIECE OR PARCEL OF LAND LOCATED IN SECTIONS
 8 45, 46, 53, 80, T7S-R2E, GREENSBURG LAND DISTRICT LAND DISTRICT,
 9 PARISH OF EAST BATON ROUGE, STATE OF LOUISIANA, MORE
 10 PARTICULARLY DESCRIBED AS FOLLOWS:
