

**HOUSE COMMITTEE AMENDMENTS**

Amendments proposed by House Committee on Administration of Criminal Justice to Reengrossed Senate Bill No. 54 by Senator Johns

1 AMENDMENT NO. 1

2 On page 1, delete line 2 in its entirety and insert the following:

3 "To amend and reenact R.S. 32:865(A) and R.S. 44:4.1(B)(19) and to enact  
4 R.S. 15:571.11(A)(4) and Part II-A of Chapter 1 of Title 32 of"

5 AMENDMENT NO. 2

6 On page 1, line 7, after "penalties;" and before "to" insert "to provide for the distribution of  
7 fines collected for operating a motor vehicle not covered by security and for violations of  
8 the Statewide Motor Vehicle Theft and Uninsured Motorists Identification Program;"

9 AMENDMENT NO. 3

10 On page 1, between lines 11 and 12, insert the following:

11 "Section 1. R.S. 15:571.11(A)(4) is hereby enacted to read as  
12 follows:

13 §571.11. Dispositions of fines and forfeitures

14 A.

16 **(4) Notwithstanding any provision of law to the contrary, all fines**  
17 **collected pursuant to R.S. 32:46 and 865, except for those fines collected**  
18 **pursuant to R.S. 32:865(B)(2), shall be distributed as follows:**

19 **(a) Thirty percent to the vendor of the automatic license plate**  
20 **recognition system as defined by R.S. 32:46.**

21 **(b) Thirty percent to the sheriff.**

22 **(c) Thirty percent to the district attorney.**

23 **(d) Ten percent to the Louisiana Public Defender Board.**

25 AMENDMENT NO. 4

26 On page 1, delete line 12 in its entirety and insert the following:

27 "Section 2. R.S. 32:865(A) is hereby amended and reenacted and Part II-A  
28 of Chapter 1 of Title 32 of the Louisiana Revised Statutes of"

29 AMENDMENT NO. 5

30 On page 6, at the end of line 15, add the following:

31 **"The funds collected pursuant to the provisions of this Paragraph shall**  
32 **be distributed pursuant to the provisions of R.S. 15:571.11(A)(4)."**

33 AMENDMENT NO. 6

34 On page 7, between lines 3 and 4, insert the following:

35 \* \* \*

1 §865. Criminal sanctions for operating motor vehicle not covered by  
2 security

3 A. Any person knowingly operating a motor vehicle and any owner  
4 allowing a motor vehicle to be operated, when such motor vehicle is not  
5 covered by the security required under R.S. 32:861 shall, upon conviction,  
6 be fined not less than five hundred dollars, nor more than one thousand  
7 dollars. **Except as provided in Paragraph (B)(2) of this Section, the funds**  
8 **collected pursuant to the provisions of this Section shall be distributed**  
9 **pursuant to the provisions of R.S. 15:571.11(A)(4).**

11 AMENDMENT NO. 7

12 On page 7, at the beginning of line 4, change "Section 2." to "Section 3."
