Repeals the Washington Parish Reservoir District.

Purpose of the Bill: Amends the provisions regarding the authority of the Washington Parish Reservoir District, which is a political subdivision of the state of Louisiana within the Department of Transportation & Development (DOTD). Specifically, the bill as amended would: a) modify the appointment of vacant board commission seats by the governor, b) provide that the board of commissioners shall have no authority to expropriate by imminent domain, c) provide that all contracts are subject to Chapter 10 of Title 38 of the Louisiana Revised Statutes, d) provide that the board meetings be conducted pursuant to the open meetings law, and e) that notice of all meetings of the commission be posted on the parish governing authority website no later than 72 hours prior to the meeting.
