Requires local school boards to require students in grades four through six to recite a specified passage from the Declaration of Independence

Present law requires local school boards to permit school authorities to allow an opportunity, at the start of each school day, for students and teachers desiring to do so to observe a brief time in prayer or meditation. Also requires local school boards to permit school authorities to allow an opportunity at the commencement of the first class of each day in all grades and in all public schools for the recitation of the Pledge of Allegiance. Proposed law requires local school boards to require students in grades four through six to recite a specified passage from the Declaration of Independence at the commencement of the first class of each day.

## **EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on expenditures of local school districts as a result of this measure. Per current law the Declaration of Independence shall be made required study in all elementary schools throughout the state. Further, schools shall permit the opportunity for the recitation of the Pledge of Allegiance which shall occur at the commencement of the first class of each day. Proposed law would require recitation of the Declaration of Independence language at that time.
