CIVIL/PROCEDURE: Requests that the Louisiana State Law Institute examine the rules of discovery in the Code of Civil Procedure

1	A CONCURRENT RESOLUTION
2	To urge and request the Louisiana State Law Institute to study the laws regarding the rules
3	of discovery in Louisiana and to submit a written report of its findings with
4	recommendations relative to establishing consistent and specific procedures and
5	rules for discovery including the discovery of expert reports, the discovery of
6	surveillance of parties, and the discovery of witness statements.
7	WHEREAS, the rules of discovery have been created to facilitate fair and just
8	outcomes of lawsuits; and
9	WHEREAS, the Code of Civil Procedure provides rules for the discovery of evidence
10	and obtaining expert reports; and
11	WHEREAS, the Code of Civil Procedure also sets forth limitations on producing
12	surveillance of a party and provides parameters for discovering recorded statements; and
13	WHEREAS, there is potential for the rules of discovery to be abused and exploited
14	for tactical advantages in lawsuits; and
15	WHEREAS, the prevention of misuse of discovery to facilitate fair and just trials
16	should be of the utmost importance to the people of Louisiana.
17	THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby
18	urge and request the Louisiana State Law Institute to evaluate and analyze the rules of
19	discovery in Louisiana, to consider these rules, and to make recommendations relative to
20	establishing fair and consistent procedures for discovery, and in particular for the exchange

- 1 of expert reports, the surveillance of parties, and the exchange and discoverability of non-
- 2 party recorded statements.
- 3 BE IT FURTHER RESOLVED that a written report of its findings and 4 recommendations be submitted to the House Committee on Civil Law and Procedure and
- 5 the Senate Committee on Judiciary A no later than sixty days prior to the 2017 Regular
- 6 Session of the Legislature of Louisiana.
- 7 BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted
- 8 to the director of the Louisiana State Law Institute.
